In partnership with Walimu (Ugandan NGO) and the Uganda MOH, the IMAI Alliance continues to provide technical support to the integrated NCD programme in Uganda. This FY, Alliance NCD activities included: 1) Meeting on additions to essential medicines list through expert consensus to update important NCD medicines in the Uganda essential medicines list/clinical guidelines; 2) Facilitator training of trainers with senior clinicians from Masaka region, Nakeseke district, Uganda Protestant Medical Bureau (UPMB), and Medical Research Council (MRC) forming the basis for further scale up. On-site training of health workers and auxiliary staff for NCD chronic care and the NCD longitudinal patient monitoring system at Masaka Regional Referral Hospital; 3) Monthly clinical mentoring, monitoring and evaluation.

The Alliance continues to support the scale up of the Quick Check+ programme which includes training and mentoring of district hospital clinical teams in the African and SE Asian regions. Grants by WCO Nepal during this FY included support for further adaptation of IMAI District Clinician Manual for Nepal and associated training materials, including the Clinician's Role in Disease Surveillance and Response and Quick Check curricula. Additionally, an in-country training of trainers with facilitators from Patan Academy of Health Sciences, Kathmandu University School of Medical Sciences, and Sukraraj Tropical and Infectious Disease Hospital followed by hospital trainings for 15 clinical teams across 7 provinces was conducted in Kathmandu.
